ELIGIBILITY: Open to brothers with at least one being affiliated with a Member Club of the Western Pennsylvania Golf Association. Golf professionals may compete, provided the team otherwise meets eligibility requirements. Both golfers must have USGA Handicap Indexes® in order to be eligible for net prizes. The field will be limited to 72 teams, and the Committee reserves the right to select the most representative field.

FORM OF PLAY: Eighteen holes of stroke play, Chapman format. Details will be available on site. Team handicaps will be determined in accordance with USGA Handicap System guidelines.

CADDIES/AUTOMOTIVE TRANSPORTATION: Teams must use either carts or club caddies. The charge is included in the entry fee.

ENTRY FROM, FEE, CLOSING DATE: Online Entries will be accepted until 5:00 p.m E.D.T. Wednesday, July 19, 2006. Entry application and fee of \$175 per team must reach the Western Pennsylvania Golf Association office by 5:00 p.m. of Wednesday, July 19, 2006, to be considered. Electronic entries have no status until receipt of entry fee. The fee includes range balls, continental breakfast, lunch, prizes, and cart/caddie fees. Checks should be made payable to the Western Pennsylvania Golf Association. A service charge of \$20.00 will be deducted from an accepted team that withdraws.

LATE ENTRIES: Late entries will be accepted at the convenience of the committee. Such entries must be accompanied by a late fee of \$20 prior to acceptance.
