**ELIGIBILITY:**

**FATHER/SON:** Open to fathers and sons, including golf professionals, affiliated with the Western Pennsylvania Golf Association.

**PARENT/CHILD:** Open to parent/child teams consisting of one male and one female or two females, including golf professionals, affiliated with the Western Pennsylvania Golf Association.

Each team must have one golfer affiliated with the Association. Both team members must have current USGA Handicap Indexes® to be eligible for net prizes.

**ENTRIES: Form, Fee, Closing Date**

Online Entries will be accepted until 5:00 P.M. E.D.T. Thursday, July 5, 2007. Players may enter online at <http://www.wpga.org>. Players must have a valid e-mail address and have an account that has been created on the WPGA site. Partners must also have an account created. Accounts can be created by contacting the WPGA at 412-826-2180 or by e-mailing [tournamentinfo@wpga.org](mailto:tournamentinfo@wpga.org) with their name, address, and e-mail address. The account name and password will be sent back to the player. Online entries may be paid by Visa, Mastercard or Discovercard.

Paper entry forms and team fee of \$175.00 must reach the Western Pennsylvania Golf Association office by 5:00 P.M. on Thursday, July 5, 2007, to be considered.

The committee reserves the right to accept late entries. Late entries will be placed on an alternates list to fill spots if they become available and must be accompanied by a late fee of **\$50.00**.

Entry fee will be refunded with a **\$15.00** service charge for withdrawals before the close of entries. Withdrawals after the close of entries, but prior to the day of the event will be subject to a **\$25.00** service charge. Withdrawals on the day of the event will receive no refunds.

**FORMAT:**

Eighteen holes of stroke play, Chapman format. Details will be available on site. Team handicaps will be determined in accordance with USGA Handicap System guidelines. The competition shall be played in accordance with the USGA Rules of Golf. In the event of a tie for the championship, a hole-by-hole playoff immediately after completion of the second round will be conducted. Players in the Father/Son or males in the Parent/Child may play from either the Blue Tees or the White Tees. Teams in which a player plays from the White tees will only be eligible for the Net prizes.

**SCHEDULE OF EVENTS (approximate):**

Continental Breakfast - 45 minutes before the first tee time.

Driving Range Open – 45 minutes before first tee time

Players should check in with WPGA staff before play to receive their scorecard and have their picture taken.

Shotgun start approximately 8:30 A.M.

**PRIZES:**

Trophies will be awarded to the winning teams. Prizes will be awarded to approximately the top 30% of the field. Prizes will consist of credits in the Green Oaks Professional shop.
