**ELIGIBILITY:**

Players eligible are current senior club champions from Member Clubs, champions (scratch) of all WPGA events in the previous year and members of the previous year's Senior Honor Roll, including Honorable Mentions.

If the current senior club champion cannot to compete, the runner-up or the previous year's club champion may replace him. If a senior player is the regular club champion of his club, he must play in the Tournament of Club Champions. If he is both the senior and regular club champion, he may enter both events. If a player appears on both the regular and senior Honor Roll's he may play in both events.

**ENTRIES: Form, Fee, Closing Date**

Online Entries will be accepted until 5:00 P.M. E.D.T, Wednesday, April 11, 2007. Players may enter online at <http://www.wpga.org>. Players must have a valid e-mail address and have an account that has been created on the WPGA site. Accounts can be created by contacting the WPGA at 412-826-2180 or by e-mailing [tournamentinfo@wpga.org](mailto:tournamentinfo@wpga.org) with their name, address, and e-mail address. The account name and password will be sent back to the player. Online entries may be paid by Visa, Mastercard or Discovercard.

Paper entry forms and team fee of \$100.00 must reach the Western Pennsylvania Golf Association office by 5:00 P.M. on Wednesday, April 11, 2007, to be considered.

The committee reserves the right to accept late entries. Late entries will be placed on an alternates list to fill spots if they become available and must be accompanied by a late fee of **\$50.00**.

Entry fee will be refunded with a **\$15.00** service charge for withdrawals before the close of entries. Withdrawals after the close of entries, but prior to the day of the event will be subject to a **\$25.00** service charge. Withdrawals on the day of the event will receive no refunds.

**FORMAT:**

18 holes of stroke play, gross scores only, morning and afternoon rounds. The competition shall be played in accordance with the USGA Rules of Golf. In the event of a tie for the championship, a hole-by-hole playoff immediately after completion of the second round will be conducted.

**SCHEDULE OF EVENTS (approximate):**

Continental Breakfast - 45 minutes before the first tee time.

Hannastown does not have a driving range, but players may hit their own balls in an area approximately 120 yards long before between the 10<sup>th</sup> fairway and the 18<sup>th</sup> green beginning approximately 45 minutes before the start of tee times.

A.M. Rounds starting approximately 8:00 A.M.

Lunch after morning round.

P.M. Rounds starting approximately 45 minutes after the completion of group's morning round.

**AUTOMOTIVE TRANSPORTATION:** Included in the entry fees, but not required. Players who walk may request a refund of the appropriate amount from the WPGA after the event.

**PRIZES:**

A trophy will be awarded to the winning player. Prizes will be awarded to approximately the top 30% of the field. Prizes will consist of credits in the Hannastown Professional shop.
